#### ABOUT THE BRAND PERFORMANCE CHECK

Fair Wear Foundation believes that improving conditions for apparel product location workers requires change at many levels. Traditional efforts to improve conditions focus primarily on the product location. FWF, however, believes that the management decisions of clothing brands have an enormous influence for good or ill on product location conditions.

FWF's Brand Performance Check is a tool to evaluate and report on the activities of FWF's member companies. The Checks examine how member company management systems support FWF's Code of Labour Practices. They evaluate the parts of member company supply chains where clothing is assembled. This is the most labour intensive part of garment supply chains, and where brands can have the most influence over working conditions.

In most apparel supply chains, clothing brands do not own product locations, and most product locations work for many different brands. This means that in most cases FWF member companies have influence, but not direct control, over working conditions. As a result, the Brand Performance Checks focus primarily on verifying the efforts of member companies. Outcomes at the product location level are assessed via audits and complaint reports, however the complexity of the supply chains means that even the best efforts of FWF member companies cannot guarantee results.

Even if outcomes at the product location level cannot be guaranteed, the importance of good management practices by member companies cannot be understated. Even one concerned customer at a product location can have significant positive impacts on a range of issues like health and safety conditions or freedom of association. And if one customer at a product location can demonstrate that improvements are possible, other customers no longer have an excuse not to act. The development and sharing of these types of best practices has long been a core part of FWF's work.

The Brand Performance Check system is designed to accommodate the range of structures and strengths that different companies have, and reflects the different ways that brands can support better working conditions.

This report is based on interviews with member company employees who play important roles in the management of supply chains, and a variety of documentation sources, financial records, supplier data. The findings from the Brand Performance Check are summarized and published at <a href="https://www.fairwear.org">www.fairwear.org</a>. ## Summary:

In the past financial year, KTC has shown advanced results on performance indicators and has made good progress. With 99% of its supply chain under monitoring, meeting the requirements for FWF members in the third+ year of membership, and a benchmarking score of 79, KTC has achieved leader status.

All of the brand's production comes from one supplier in China (owned by the same holding company) and a small portion of accessories from a supplier in Germany. That apart, the brand has established a direct connection between the brand and production location with the positions of Chairman of the brand and Managing Director of the supplier, and Head of CSR of brand and factory being managed by the same people. This setup creates a direct link between brand and supplier both at leadership and compliance team levels and facilitates full transparency, extended leverage and an inherent commitment to improving conditions in the supply chain. That apart, having a team at the production location facilitates the brand to be aware of working conditions and also take preventive measures where needed.

The brand reviewed audit findings pertaining to living wages, did an analysis on wage levels at the factory and concluded that the wages are not in the lower range in comparison to the local wage levels. The brand is yet to set a target wage and develop a strategy to finance wage increases at the supplier location.

FWF encourages the brand to continue working on findings pertaining to overtime and also explore opportunities to work on wage increases at the supplier location. As the supplier is based in Guangdong province where this is no living wage benchmark published by authorities, FWF recommends that the brand uses the Asia Floor Wage benchmark as a reference to set a target wage.

#### PERFORMANCE CATEGORY OVERVIEW

Leader: This category is for member companies who are doing exceptionally well, and are operating at an advanced level. Leaders show best practices in complex areas such as living wages and freedom of association.

Good: It is FWF's belief that member companies who are making a serious effort to implement the Code of Labour Practices—the vast majority of FWF member companies—are 'doing good' and deserve to be recognized as such. They are also doing more than the average clothing company, and have allowed their internal processes to be examined and publicly reported on by an independent NGO. The majority of member companies will receive a 'Good' rating.

Needs Improvement: Member companies are most likely to find themselves in this category when major unexpected problems have arisen, or if they are unable or unwilling to seriously work towards CoLP implementation. Member companies may be in this category for one year only after which they should either move up to Good, or will be moved to suspended.

Suspended: Member companies who either fail to meet one of the Basic Requirements, have had major internal changes which means membership must be put on hold for a maximum of one year, or have been in Needs Improvement for more than one year. Member companies may remain in this category for one year maximum, after which termination proceedings will come into force.

Categories are calculated based on a combination of benchmarking score and the percentage of own production under monitoring. The specific requirements for each category are outlined in the Brand Performance Check Guide.

Comment: KTC Unlimited has a small portion of accessories is sourced from a supplier in Germany. The remaining 99% of the brand's total FOB is sourced from one production location in China, owned by the same holding company. Even though the 99% FOB volume represents only 5% of the total production capacity of the production location, Fair Wear has decided to award full points for the following reasons:

The brand has exhausted all options for increasing leverage given that they work with a single supplier where the nearly total purchasing volume is placed. Furthermore, the brand has established a direct management system between the company brand level and the production location with the positions of Chairman of the brand and Managing Director of the supplier, and Head of CSR of brand and factory being managed by the same people. This setup creates a direct link between brand and supplier both at leadership and compliance team levels and facilitates full transparency, extended leverage and an inherent commitment to improving conditions in the supply chain.

Comment: All of the brand's production comes from one supplier in China (owned by the same holding company) and a small portion of accessories from a supplier in Germany. That apart, the brand has established a direct connection between the brand and production location with the positions of Chairman of the brand and Managing Director of the supplier, and Head of CSR of brand and factory being managed by the same people. This setup creates a direct link between brand and the supplier both at leadership and compliance team levels and facilitates full transparency, extended leverage and an inherent commitment to improving conditions in the supply chain.

The factory team stays updated on changes to labour laws and local compliance requirements by notifications received from government departments. That apart, having a team at the production location facilitates the brand to be aware of working conditions and also take preventive measures where needed.

Comment: Given the brand's direct presence in the factory, compliance is evaluated on an almost daily basis (informally) and systematically.

Recommendation: FWF recommends the member hold a formal evaluation once a year to track challenges and successes in the implementation of the Code of Labour Practices. Such top-level, periodic evaluation can support the brand to gain a holistic insight into areas where teams need support or inform the brand on aspects pertaining to resource allocation.

Comment: Given the supply chain set-up, the brand can analyse its direct impact on working hours and also contribute to better production planning at the production location by discussing and distributing/ grouping production in a manner that achieves maximum optimization for the supplier. That apart, the supplier also follows a format of production planning where production timetable/ schedule needs to be agreed in advance and orders confirmed to block capacity. The capacity is blocked on a first-come, first-served basis. The brand provides this timetable by back calculating considering the presentation date, salesman sample dates, instore dates given by sales team etc. That apart, the brand has an experienced design and buying team, which limits the need for changes. The integrated structure and direct link with the supplier through shared teams allow for quick and timely decision making.

Comment: FWF audit reports indicate the presence of overtime at the supplier. The brand and supplier identified that aspects related to the complexity of the process/ material (e.g. the material is not able to withstand a particular process) and fluctuations between forecasted volume and the actual volume of the order, contribute to overtime. On its part the brand tries to take the following measures:

- 1) In production planning, includes time for queuing of certain styles/ wait that might be needed
- 2) Moved development process and style signoff dates to the earliest time possible

At the same time, the brand acknowledges that the supplier as part of its sustainable practices does not sub-contract or have a temporary workforce and cannot plan for below capacity for financial reasons as well as owing to the fact that insufficient work/idle time will result in workers leaving the factory.

Comment: Given the supply chain set-up, the brand has detailed insight into the price and cost breakdown of all products, working minutes required and labor cost of the supplier. Having complete transparency allows the brand to ensure that at the least minimum wages are covered.

Comment: The brand and supplier did a wage analysis and concluded that the Anker living wage estimates are not relevant given the geographic location of the factory. The brand and supplier collected data on average wages in the city (across industries) and did a comparison with the average wage levels at the factory. The brand and supplier concluded that the wages are not in the lower range in comparison to the local wage levels. At this point, the brand and supplier does not see that it is immediately possible to significantly increase wages at this factory.

**Recommendation**: FWF encourages the brand to discuss with the supplier about different strategies to work towards higher wages.

Comment: The main audit findings related to awareness of workers on code of labour practices, worker complaints pertaining to the food provided, living wages and social contribution, worker representation and overtime. The brand actively followed-up on the audit findings, discussed the root causes and addressed issues where feasible. Some issues are yet to be remediated.

Recommendation: It is advised to include worker representation in the remediation process. Either to engage workers in identifying and implementing improvements or to verify realised improvements.

Comment: In terms of risks related to production in China, the brand and CSR staff actively present in the factory focus on and address day-to-day issues. The brand has not identified any specific areas of risk for the production location. The factory team (also the brand CSR team) is updated on changes to labour laws and local compliance requirements by notifications received from government departments. With reference to freedom of association, the brand and supplier do not want to interfere in the process. That apart, the brand also feels that workers are disinterested in training and awareness programmes and hence has not explored involving them in the context of risk mitigation.

Comment: The brand works closely with two other FWF members to resolve audit findings at the supplier location. The brands discuss and keep each other updated using group emails and when needed, organize a call.

Recommendation: FWF recommends members to document status of joint follow-up actions. Even though one brand commonly takes the lead it is important to be kept informed of the status in order to be aware of required implementation steps before communication with or visits to the factory.

- Ensure up to date information on the labour conditions in the location either by a regular visit and/or a report by a third party;
- Be informed of FWF membership and return the completed CoLP questionnaire before production orders are placed;
- Be aware of specific risks identified by FWF;
